

ORDINANCE NO. 2 OF 2012

AN ORDINANCE TO CREATE NEW MUNICIPAL VOTING DISTRICTS

BE IT ORDAINED by the Board of Aldermen (City Council) of the City of Port Allen, West Baton Rouge, Louisiana, in regular session duly convened, in keeping with the authority granted by applicable federal and state laws and regulations, and in order to establish an additional polling location to correct the disenfranchisement of voters, that it does hereby enact an ordinance.

SECTION 1. The boundaries of the election districts for the four single member districts of the Board of Aldermen (City Council) of the City of Port Allen shall hereby be changed in accordance with Louisiana law and utilizing the population data of the 2010 Federal Decennial Census.

SECTION 2. The boundaries of the new election districts for the four single member districts of the Board of Aldermen (City Council) of the City of Port Allen are hereby described as follows:

DISTRICT 1 is described as follows: Beginning at the intersection of Rosedale Rd and Eleanor St, proceed East on Rosedale Rd to the intersection with Union Pacific RR, the proceed South along Union Pacific RR to the intersection with Louisiana Ave, then proceed West along Louisiana Ave to the intersection with N 12th St., then proceed South along N 12th St., to the intersection with Michigan Ave, then proceed East along Michigan Ave to the intersection with N 10th St, then proceed South along N 10th St to the intersection with Oregon Ave, then proceed West along Oregon Ave to the intersection with 14th St, then proceed South along 14th St. to the intersection with Court St./Louisiana Hwy 76, then proceed West along Court St./Louisiana Hwy 76 to the intersection with the Port Allen municipal limits, then proceed Northerly along the Port Allen municipal limits to the intersection of Louisiana Ave., then proceed East on Louisiana Ave to the intersection of Eleanor St., then proceed North on Eleanor St to the Point of beginning.

DISTRICT 2 is described as follows: Beginning at the intersection of the Port Allen municipal limits and Court St/LA Hwy 76 proceed East along Court St/LA Hwy 76 to the intersection with 14th St, then proceed South on 14th St to the intersection with Avenue B, then proceed West along Avenue B to the intersection with Heliotrope St, then proceed South on Heliotrope St to the intersection with Avenue G, then proceed East on Avenue G to the intersection with Gladiolus St., then proceed North on Gladiolus St to the intersection with Avenue D, then proceed East on Avenue D to the intersection with S 14th St, then proceed North on S 14th St to the intersection with Avenue C, then proceed East on Avenue C to the intersection with Union Pacific RR, then proceed North along Union Pacific RR to the intersection with Avenue B, then proceed East on Avenue B to the intersection with S. Alexander Ave, then proceed South along S.

Alexander Ave to the intersection with Avenue C, then proceed East along Avenue C to the intersection with S. River Rd, then proceed North along S. River Rd to the intersection with LA Hwy 987-6, then proceed East to the middle of the channel of the Mississippi River, then South along the middle of the channel of the Mississippi River to the I-10, then proceed West along I-10 to the intersection of Capital Dr, then proceed in a Southerly direction following the Port Allen municipal limits and back Northerly along the Port Allen municipal limits, then Westerly along the Port Allen municipal limits, as it lies South of I-10, then Northerly along the Port Allen municipal limits, encompassing the entirety of the Port Allen municipal limits South of I-10, to the point of beginning.

DISTRICT 3 is described as follows: Beginning at the intersection of Rosedale Union Pacific RR, proceed East along Rosedale Rd to the intersection with 7th Street, then proceed North, then East, then South, along the Port Allen municipal limits to the intersection with Rosedale Rd, then proceed East along Rosedale Road to the intersection with N. River Rd, then proceed East along the Port Allen municipal limits to the middle of the channel of the Mississippi River, then proceed South along the middle of the channel of the Mississippi River to the intersection with District 2, being also the precinct line for Precinct 4-2, then proceed West along said line to the intersection with S. River Rd, then proceed South along S. River Rd to the intersection with Avenue C, then proceed West along Avenue C to the intersection with western portion of S. Alexander Ave, then proceed North along the western portion of S. Alexander Ave to the intersection with Avenue B, then proceed West along Avenue B to the intersection with the Union Pacific RR, then proceed North along the Union Pacific RR to the intersection with Court St/LA Hwy 76, then proceed East along Court St/LA Hwy 76 to the intersection with 7th Street, then proceed North on 7th St to the intersection with California Ave, then proceed West on California Ave. to the intersection with 8th St., then proceed North on 8th St. to the intersection with Oregon Ave, then proceed West on Oregon Ave to the intersection with the Union Pacific RR, then proceed North along the Union Pacific RR to the point of beginning.

DISTRICT 4 is described as follows: Beginning at the intersection of 14th St and Oregon Ave, proceed East along Oregon Ave to the intersection with N 10th St, then proceed North on N 10th St. to the intersection of Michigan Ave., then proceed West on Michigan Ave. to the intersection of N 12th St., then proceed North along N 12th St. to the intersection of Louisiana Ave., then proceed East on Louisiana Ave. to the intersection of Union Pacific RR, then proceed South along Union Pacific RR, to the intersection of Oregon Ave., then proceed East on Oregon Ave. to the intersection of 8th St, then proceed South along 8th St to the intersection with California Ave., then proceed East on California Ave. to the intersection with 7th St., then proceed South on 7th Street to the intersection of Court St/LA Hwy 987-4, then proceed West along Court St/LA Hwy 987-4 to the intersection with the Union Pacific RR, then proceed South along the Union Pacific RR to the intersection with Avenue C, then proceed West on along

Avenue C to the intersection with 14th St, then proceed South along 14th St to the intersection with Avenue D, then proceed West along Avenue D to the intersection with Gladiolus St, then proceed South along Gladiolus St to the intersection with Avenue G, then proceed West along Avenue G to the intersection with Heliotrope St, then proceed North along Heliotrope St to the intersection with Avenue B, then proceed East along Avenue B to the intersection with 14th St, then proceed North along 14th St to the point of beginning.

SECTION 3. The election districts established herein shall be effective for use in the next regularly scheduled elections for members of the Board of Aldermen (City Council) of the City of Port Allen, scheduled in the Fall of 2012; however nothing herein is intended to affect the terms or the districts of the members of the Board of Aldermen (City Council) of the City of Port Allen elected from the districts existing on the date of adoption of this ordinance.

SECTION 4. All ordinances or parts thereof in conflict herewith are hereby repealed.

SECTION 5. Should any provision of this ordinance, or the application thereof, be held invalid, such invalidity shall not affect the validity of the remaining portions of this ordinance.

This ordinance was introduced on January 11, 2012.

A public hearing was held on February 8, 2012.

The above ordinance having been submitted to a vote, the result thereon was as follows:


